If a Contributor donates to multiple organizations and their total donations are more than \$50,000, the above credit on line 3 may not be honored. It is the responsibility of the Contributor to track their donations and their total expected tax credits; the Neighborhood Assistance Organization is only responsible for tracking the credits for the donations it receives directly. Further, NAP Tax Credits shall only be applied against any state tax liability owed by the contributor after the application of any credits that, under IC 6-3.1-1-2, must be applied before the credit provided under the Neighborhood Assistance Program. Finally, credits are nonrefundable, meaning if a donor's credit is more than their state tax liability, they will not be refunded the difference.</i>
